

**Kodiak CERAMIC BRAKE PADS  
LIMITED LIFETIME WARRANTY**

Kodiak Trailer Components warrants to the original customer of the Ceramic Brake Pads, that the products are free from defects in design, material and/or workmanship and will be replaced if they should ever wear out under normal non-commercial trailer operation for as long as you own your trailer. The product will be considered worn out when the lining minimum wearable thickness is 1/16" or less above the disc plate. Kodiak will exchange new brake pads for defective or worn out brake pads, excluding labor cost, shipping, and/or incidental expenses, provided the original customer meets each of the following conditions:

- (1) Have the product correctly installed on your trailer by the original equipment manufacturer or qualified mechanic.
- (2) Save the installation invoice, itemized bill or any other proof of installation.
- (3) Complete and return the registration card of this warranty to Kodiak within 30 days of purchase/installation.
- (4) Have your trailer's braking system, including the friction lining, inspected, serviced, and adjusted periodically in accordance with your trailer manufacturer's recommendations.
- (5) Operate your trailer only for non commercial use.
- (6) Submit your claim with the worn out or defective pads to Kodiak at the address listed on the attached claim form.

**THIS LIMITED WARRANTY DOES NOT APPLY:**

- (1) To trailers used for public service, public conveyance, commercial or government use.
- (2) To damage, failure or excessive wear caused by trailer accident, abuse, unreasonable or excluded use of trailer, faulty installation, or improper maintenance and adjustment.
- (3) To warrant or guarantee the workmanship of the installer.

**THIS LIMITED WARRANTY:**

- (1) Is for replacement products only and has no refund or cash reimbursement value.
- (2) Is not transferable or assignable by the original customer to any other person or to any other trailer.

It is expressly agreed that no warranty or merchantability or fitness for use, nor any other warranty, express or implied, is made by Kodiak Trailer Components, hereunder. The foregoing states Kodiak Trailer Components' entire and exclusive liability and the original customer's exclusive and sole remedy for any claim or damage in connection with the sale of the products hereunder.

Kodiak Trailer Components shall in no event be liable for any special or consequential damages whatsoever.

LIMITED WARRANTY**

KODIAK warrants its **E-Coat / Silver Cad** sets against defects in materials or workmanship for a period of three (3) years from the date of purchase, and agrees to repair or replace any defective unit without charge subject to timely receipt by Kodiak of the attached warranty information card, properly completed.

KODIAK warrants its **All Stainless Steel Disc Brake** sets against defects in materials or workmanship for a period of six (6) years from the date of purchase, and agrees to repair or replace any defective unit without charge subject to timely receipt by Kodiak of the attached warranty information card, properly completed.

**TO VALIDATE WARRANTY, PLEASE COMPLETE ENCLOSED WARRANTY CARD AND RETURN TO KODIAK WITHIN 30 DAYS OF DATE OF PURCHASE.**

IMPORTANT, the warranty does not cover damage or loss resulting from accident, misuse or abuse, lack of reasonable care, corrosion, the affixing of any attachment not provided with the product, loss of parts, normal wear, or subjecting the product to any but the specified application, nor does it cover field labor or inbound freight charges. This warranty is non-transferrable.
